



ACCEPTANCE OF TERMS AND CONDITIONS

4. The Organizer reserves the right to amend the T&Cs from time to time and modify the Program at its sole discretion at any time. Notice of any such amendments, cancellations or suspensions will be posted on the Organizer's communication channels (Facebook and Email newsletter).
5. The Organizer reserves the right to cancel or suspend the Program before the Program Period as set forth in Article 8 of this T&Cs. Notice of any such cancellations or suspensions will be posted on the Organizer's communication channels (Facebook and Email newsletter).

ELIGIBILITY

 - (a) residing in Malaysia and have a right to work in Malaysia,

 - b) Pass your probation period;
11. Providing you have met the above conditions, the Sign-on bonus payment will be included in your regular monthly payslip upon successful completion of the above conditions.
12. The right to participate in the Program and any associated Sign-on Bonus is personal to the participant and may not be assigned or transferred.



13. The above bonuses are subject to repayment in full to EPAM Malaysia should an employee who received it:
 - a. Resigns from his/her employment with EPAM within the first 6 months of employment, calculated from their start date ; or
 - b. Takes a long-term, continuous absence from work of 30 calendar days or more, except for (i) absences beyond the control or influence of the employee or (ii) statutory maternity leave, both within the first 6 months of employment with EPAM.
